Data doesn't lose itself

Data security risk today is based on human behavior. Modern workers put data at risk in many ways—whether through mistakes, malicious intent or account compromises. Proofpoint 2024 research showed that careless users caused 71% of data loss incidents. Departing employees accounted for 87% of cloud-based file exfiltration events.¹

Data sprawl is now a major challenge. Today's knowledge workers store data across public clouds, file-share services and on-premises databases. They also contribute data to large language models (LLMs). This fragmentation creates blind spots for IT and security teams. One in three breaches involves shadow data and results in a 16% higher average cost per breach.²

Many data security tools don't account for human behavior and intent. This means they can't distinguish safe activity from attempts at data theft. The result is false alerts, long investigations and inefficiency for security teams. According to Gartner, by 2027, 70% of Chief Information Security Officers (CISOs) in larger enterprises will adopt a consolidated approach to addressing both insider risk and data exfiltration.³




Figure 1: The DSPM dashboard shows types of valuable or sensitive data, its monetary value and risk, and who can access it.




Figure 2: In this screenshot from the Data Security Workbench console, a user browses to a website titled "How to hide deeply a file/folder in Windows," and then downloads a file from the company's Sharepoint drive. Finally, they copy a confidential file "Customer List – invoicing.xlsx" to a USB drive. This timeline of user behavior and identification of sensitive content shows an analyst that this user is trying to circumvent company policy and that further investigation is required.

- DSPM identifies and removes redundant data and abandoned backups and snapshots. This reduces attack surfaces and lowers cloud storage costs.




Figure 3: Data Security Workbench streamlines alert management across email, cloud and endpoints without the need for multiple consoles. In this example, an analyst filters alerts for a specific user. The dashboard shows that the user uploaded sensitive data to their corporate email account and tried to copy a file to a USB drive before being blocked.

Restrict inclusion of protected information in GenAl prompts made through browsers or installed apps. Prevent the use of confidential data in custom LLM training.

Promote end-user productivity by ensuring endpoint performance and application access. The single, lightweight user-mode agent for DLP and ITM avoids the software incompatibilities, system crashes and reduced endpoint performance associated with kernelmode agents. Instead of broadly blocking applications, you can provide users with simple nudges. An example is a real-time reminder that sensitive information should not be included in a ChatGPT prompt. You can also prompt users to provide business justifications for copying sensitive data.
