It blocks compromised third-party senders from using your domains to send malicious email. And it makes compliance easier by DKIM-signing all email to help you meet DMARC requirements.

Proofpoint SER puts you in control of your email identity, ensuring your customers, partners and employees only receive authentic email from you. Plus, it protects your sensitive data by letting you apply payload encryption and email data loss protection (DLP).

Secure email from risky environments

You may have numerous applications and third-party email providers authorized to send mail using your domains—but not all follow strong security practices. This creates opportunities for account compromise or platform abuse. As a result, attackers can send malicious email that appears legitimate and passes authentication checks.

Proofpoint SER closes this gap with a controlled, closed-loop relay system. Only verified business entities can send through our platform—eliminating the risks posed by open or free relay services.

SER securely accepts mail from your authorized applications via SMTP authentication and TLS (STARTTLS). And it applies Proofpoint's advanced anti-spam and anti-virus protection to every message. It also blocks malicious attempts to send email as your organization and consolidates legitimate application traffic behind dedicated, reputable IPs, masking and protecting your brand from bad actors.




Figure 1. Ensure secure, clean and compliant transactional email.

It automatically enables DKIM signing for outbound messages and ensures SPF alignment. Meet regulatory compliance

SER ensures that all outbound messages are DKIM signed so that they align with SPF requirements. Plus, it provides support for inserting an unsubscribe button in message headers as well as managing lists from a centralized location.
