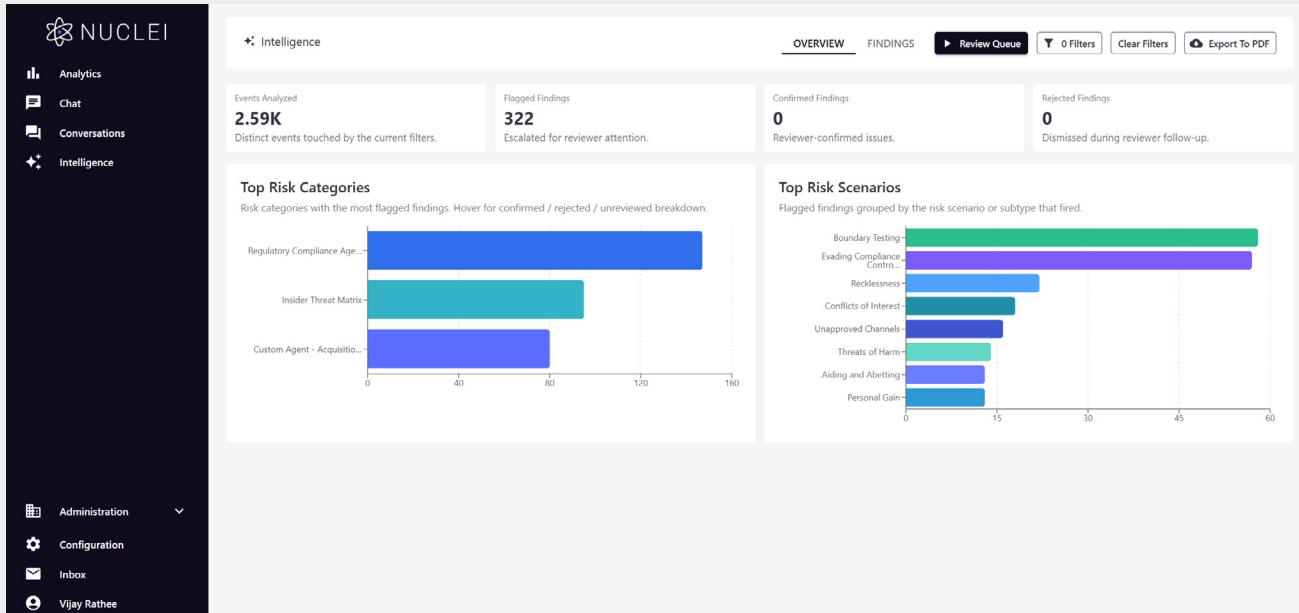

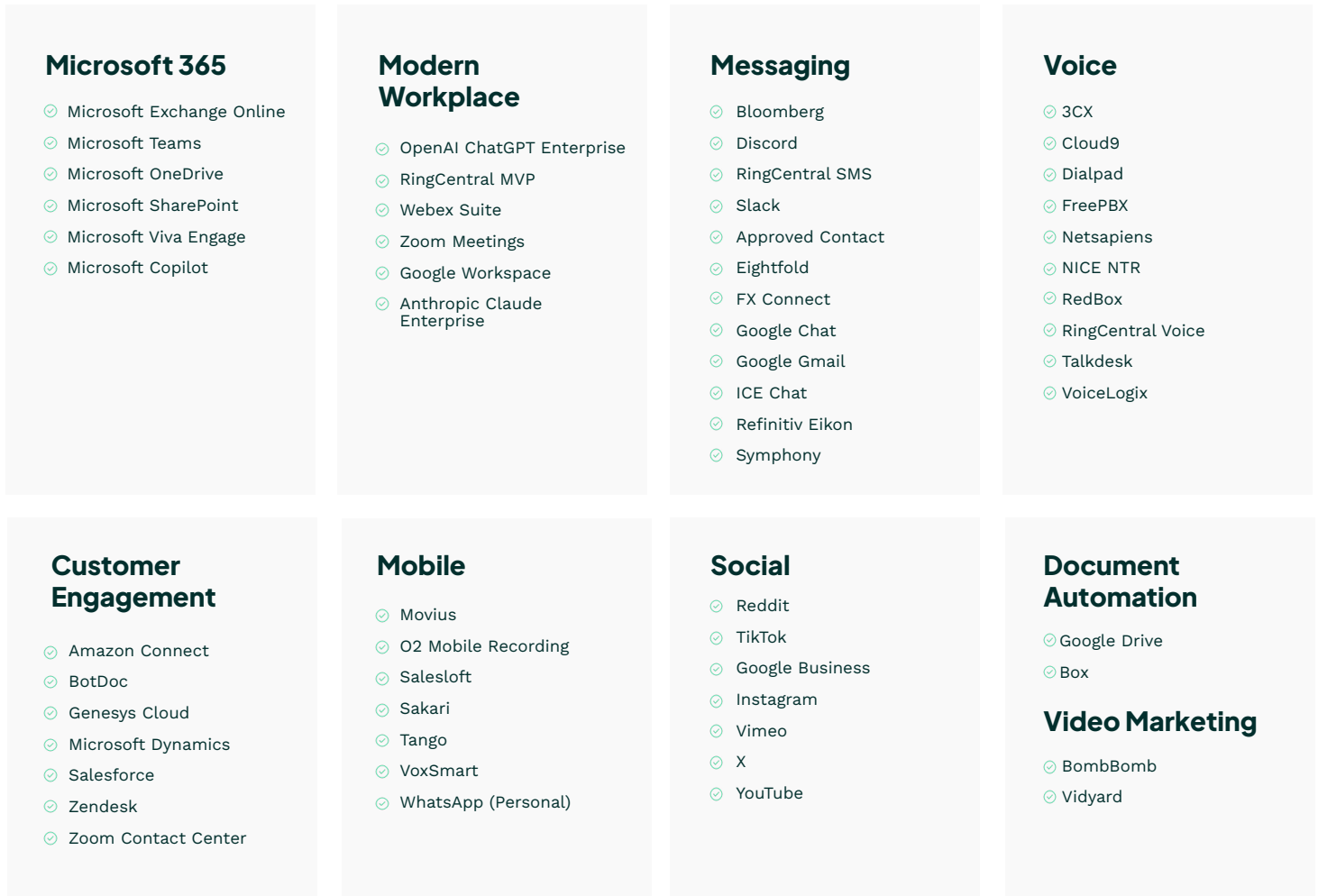
Capture provides you with access to LLM-driven reasoning beyond traditional classification methods. You can use these insights to inform and optimize downstream services such as supervision systems.
